#### 1. 11:00am Call to Order, Opening Remarks, Roll Call and Approval

President Wahlgren called the meeting to order. A welcome to the attendees. Vice President Law called the roll of the Board and delegates.

Updated the COP on amended agenda, with an addition of a Bylaw change under Governance update.

<u>President Wahlgren called for a motion to approve the consent agenda as amended and minutes for the 2016 Grassroots BOD and COP meetings in Washington, DC, and the 2016 Fall BOD meeting in Washington, DC.</u>

<u>Seconded: Florida Atlantic University</u> <u>Motion passes unanimously</u>

#### 2. 11:25am Presidential Address

President Wahlgren delivered a report on the state of the AIAS at the midpoint of the 2016-2017 academic year.

#### 3. 11:30am Governance

President Wahlgren and Director Elder reported on the work of the Governance Committee. President Wahlgren provided an overview of the process and proposed Vision Statement, and opened the floor for the Council of Presidents to discuss.

President Wahlgren noted that the motion to adopt the proposed Vision Statement was lost in the BOD.

Santa Barbara City College stated that the Vision Statement should allow for anyone who reads it to be impacted on a visual level on what the experience would be like in the future – it needs to be actionable, accountable, and tangible. SBCC continued stating that it must be able to be visualized as achievable.

Lawrence Tech stated that the proposed Vision Statement is missing "design", which is something that connects us all.



Texas Tech suggested to approach it as a design thinking exercise, parallel to design problems that we face in studios. Texas Tech continued stating that the Vision Statement is essentially a "parti' for what the AIAS stands for, suggesting that we are designing and constructing our future, and there should be an open opportunity to incorporate the fact that we are design thinkers, not simply architects.

Director Elder provided clarification on background and connotation of wording. MassArt remarked that the statement may be too short as this organization is more than this.

Director Elder and President Wahlgren extrapolated that the GOVCOMM is developing core values in tandem with the Vision Statement.

University of Detroit Mercy agreed with the personal/professional development and suggested adding mentorship because it's essential.

Carnegie Mellon University remarked that collaboration is only mentioned but should be focused on.

Georgia Tech spoke to a positive future and a focus towards a zygote of designing for the future, and added a +1 to UDM's notion of connecting students to professional community. Kent State believed that the statement is summed up by the word "uniting", bringing people together.

Auburn University suggested that a lot of these aspects are not visible to the outside eye, and the statement should be related to the Mission Statement, "advancing" present and future.

President Wahlgren gave a governance update.

<u>President Wahlgren called for a motion to adopt the Bylaw change as brought about by</u> the BOD in the FORUM Board Meeting.

#### AMENDED Bylaw 2.221 Full Member Chapters

Each full member chapter (which may hereinafter be referred to as "Member Chapter", "Chapter in Good Standing", or simply "Chapter") as an organization shall be a member of the AIAS.

Chapters shall be comprised of more than 10 individual chapter members <u>(one of which is</u> <u>the current Chapter President)</u> enrolled in a university, junior college, technical school, or other post-secondary institution with an interest in architecture and related disciplines.

Seconded: University of Hartford

#### DISCUSSION

Director Seidel provided background to the origin of the motion.

Lawrence Tech asked about the inclusion of the entire executive board.

Director Seidel agreed that the National Office can definitely enforce that, however the logistics of tracking the core four would be difficult and intensive.

Santa Barbara City College suggested that the challenge of getting members registered lies in the technical breakdowns, and that they have lost people overtime due to frustration with early experience. SBCC suggested that perhaps it is not a bylaw change, but the problem lies in the operational context.

Roger Williams University remarked that the process is continually progressing, and suggested that as a Chapter President and a leader, and thus should lead by example. Louisiana State directed the discussion towards expanding this Bylaw change to the entire executive board as there are lots of local struggles.

Past President Mitchell provided a Point of Clarification for a chapter in good standing, and stated that this amendment is to ensure this process is smooth.



Director Seidel reminded that chapter by-laws should be in support of the BOD's recommendation and the COP should to follow suit with to update them. Andrews University is in support for including the executive board as it becomes an easier solution for the local chapters.

Director Elder called the question to leave the discussion.

Vice President and Director Gentile reported on the work of the Membership Committee.

New Jersey Institute of Technology suggested reaching out to organizations such as "Schools that Can".

Lawrence Tech mentioned existing local programming with "ACE Mentorship Program" and suggested outreach.

Auburn University suggested using school administration for marketing and promotion. Dunwoody University asked if any discussion has revolved around diversity in architectural education and the profession.

Vice President Law agreed to engage in further conversations regarding pipeline and diversity discussions with the Membership Committee.

Director Seidel and Chair Widaski presented the work of the Advocacy Task Force.

Director Seidel and Chair Widaski presented a resource for chapter leaders to start discussions and communicate through panel discussions.

Vice President Law, Director Daher and Chair Lopez presented the work of the Global Council.

#### 10. 1:20pm Events Update

Executive Director Serfass announced the site for FORUM 2018 in Seattle, WA. Serfass and President Wahlgren presented an update on the Spring Quad Conferences, a recap of the 2016 Fall Programming, and an update on Grassroots 2017.

Serfass added that FBD grants will be given through application for Grassroots conference attendance.

#### 1:30pm Break

#### 11. <u>1:45pm Spring Membership</u>

Vice President Law introduced the Spring Membership Drive, the drop of membership fees to \$32, and opened up the discussion to the COP.

Andrews University expressed hesitation that members will simply register for the Spring and not the whole year.

President Wahlgren explained that it is a cost per unit comparison, as the full year membership includes all conferences, whereas the Spring only includes Quad Conferences and Grassroots.

University of Wisconsin-Milwaukee suggested a membership per semester, as many students graduate after the Fall.

Executive Director Serfass reinforced that this may appeal to diverse universities interested in the Research Symposiums.

Rochester Institute of Technology +1 – focus on Master's programs and thesis-oriented students.

Kent State University suggested a flat rate for the entire year with a lower overall cost, as well as a multi-year membership.

Serfass clarified that a Membership Fee Survey was released in 2014-2015.

Temple University noted that they have seen big increase in membership during the Spring, highlighting that the current structure works.

University of Detroit Mercy noted their tendency to lose membership engagement in the Spring, due to a drop in local programming and existing travel abroad opportunities and co-op at their university. UDM highlighted a "subset" of membership in Florence and suggested providing programming while abroad. Kent State +1

<u>President Wahlgren called for a straw poll for chapters affected by study abroad programs</u> in the Spring.

Vice President Law redirected the discussion toward how this Spring membership drive message can be most valuable to local chapters.

President Wahlgren asked if the struggles of membership is more financial than the message.

Oklahoma State stated that there is not a lasting investment among the student mindset. Lawrence Tech suggested that membership value comes from local chapter programming in the Spring.

Georgia Tech recommended making events exclusive for members.

Clemson University suggested that value is hard to communicate and demonstrate,

highlighting that the message is just as important.

Nebraska-Lincoln +1

Carnegie Mellon University noted that "seeing is believing", and all of these discussions at COP are lacking in studio and in projects, and challenged the National Office make this value more transparent to the general membership.

President Wahlgren challenged the COP to be that bridge for connection between national initiatives and local programs.

#### 12. <u>2:15pm Executive Report</u>

Executive Director Serfass briefed the Council on general operational objectives regarding staff, CRIT Editor-in-Chief, and the exploration on a mobile app.

Serfass introduced staff members and roles to the COP.

#### 13. 2:30pm New Business

President Wahlgren opened up the floor to any orders of New Business.

Rochester Institute of Technology opened a discussion on membership dues.

RIT provided background, and suggested a \$47 annual package, \$32 fall AND spring semester package.

Kent State University agreed that there is a need for evaluation as there are unique instances, and suggested installment packages, ie. 10\$ over 4 months.

University of Hartford suggested that having Spring membership fees drop makes it more difficult to generate membership rise at the beginning of year, and suggested a flat rate. University of Cincinnati remarked that if members cared enough about the AIAS they would pay the full year, and suggested the underlying problem is the *communication of value* – the message is not strong enough.

Keene State +1

Director Seidel wondered what the disconnect is at the local level between the value of events, and asked if there was anything that the National Office can do with local chapters to bridge that gap.

Ryerson University expressed a need to find more tangible aspects of what a national AIAS membership can bring.

Ohio State expressed a struggle to convey what our membership is, and asked how National can help facilitate programs and events to make the burden easier on local chapters.

University of New Mexico +1



University of Wisconsin-Milwaukee suggested a fee of \$5 a month, and noted that preplanning allows for their members to see value, ie. listing aspects members receive monthly from your chapter.

University of Massachusetts-Amherst suggested that the National Office provide a cookiecutter message for all chapters to use, noting the importance of a high quality video to explain the AIAS structure and membership value.

Texas A&M enjoyed the infographics seeing your money at work, and understanding where your money goes to.

University of Houston remarked that school administrations do not see the value of AIAS, and suggested National advocate stronger to school leadership.

Ball State asked about the possibility to provide an incentive of group discounts, as a drive for each chapter to come together to gain membership at once. Nebraska-Lincoln +1

<u>University of Kansas moved to charge the Finance Committee as well as the National</u> Office to create a packet of graphics that concisely communicate membership value, both tangible and intangible, to be distributed.

Seconded: University of Nevada-Las Vegas

DISCUSSION

Kent State University amended the motion to include communication media, ie. Video. University of Kansas accepted the amendment.

<u>Aye</u> <u>Nay 0</u> <u>Abstentions 0</u>

Motion passed unanimously.

President Wahlgren motioned to adjourn the 2016 FORUM COP meeting.



#### Dear AIAS Council of Presidents,

#### LOOKING BACK

#### STAFFING

The national office welcomed two new employees this past year. Tim Matthews came on board as our Director of Art & Creative, taking the reigns on most graphic design and video production. Ashley Ash joined the team as our new Membership Manager, serving as the main administrator of our membership database and the primary customer service arm fielding the daily calls and emails from our members.

#### 60<sup>th</sup> ANNIVERSARY

As the 60<sup>th</sup> year of the AIAS comes to a close, we are proud to have celebrated it robustly with three unique programs – the 60<sup>th</sup>: Legacy digital series highlighting AIAS alumni who have gone on to achieve significant accomplishments since graduation; the 60<sup>th</sup> Anniversary Opening Night Celebration & Silent Disco at FORUM Boston; and AIAS Imagine: Top 60 at 60, an award program recognizing the top 60 AIAS members across the country through a special one-of-a-kind conference in Orlando, FL co-hosted with the Walt Disney Imagineers.

#### FREEDOM BY DESIGN

The initial year of our partnership with NCARB resulted in a total of \$50,000 in grants directly to chapters and members. \$30,000 was distributed to project teams engaging in accessibility-focused design-build projects. \$10,000 was distributed to project teams engaging in learning/educational-focused design-build projects (mostly for elementary schools), and \$10,000 was awarded to 33 Freedom by Design directors to attend the 2017 AIAS Grassroots Leadership Conference.

#### AIAS RESEARCH SYMPOSIA

The AIAS Research Symposia were launched this year with the inaugural events being held at Virginia Tech's Washington-Alexandria Architecture Center and Stanford University. Although attendance was minimal, much was learned and gleaned from the experience to inform the next iteration of the events in 2017-2018.



#### LOOKING AHEAD

#### STAFFING

Although the national office welcomed two new employees in 2016-2017, we will be saying goodbye to Natalie Neumann, our Director of Digital Media in August. Natalie will be heading back to graduate school at the University of Texas-Austin to pursue a Masters in Social Work & Public Health. A transition plan has already been formulated to ensure no lapse in business continuity.

#### **CRIT LIVE & CRIT SCHOLAR**

The AIAS Research Symposia will continue into a second year hosted in the fall at Cornell University, the University of Arizona, University of Cincinnati and Georgia Tech. This year's events are being rebranded as CRIT Live to more formally embrace CRIT as the brand surrounding AIAS research. A new CRIT product called CRIT Scholar will also be announced at Grassroots, extending the portfolio behind the CRIT brand to CRIT Journal, CRIT Live, and CRIT Scholar.

#### NEW AIAS EVENTS

At Grassroots we will be announcing two new AIAS events in 2017-2018 - one that attempts to enhance our career programming and one that attempts to add value to our international membership. Please be in attendance at Saturday's general session when we make these exciting announcements.

#### FORUM TEXAS (AUSTIN)

The 2017-2018 year will feature FORUM Texas, located in Austin, Texas from December 29-January 1<sup>st</sup>. The student planning team is hard at work putting the programming together as we speak. A few highlights to look out for include a pre-day bus trip on the 28th to San Antonio, an Honor Awards event on the 29<sup>th</sup> at Ion Art in Austin, a local architecture firm tour throughout Austin, and a Beaux Arts Ball that is currently loosely themed as "Dreamland".

#### **DIGITAL MEDIA**

We are always looking to add new digital media features as the year progresses dependent upon the great content we can collect from you all. In particular, later this month we'll be launching a new video series in partnership with Autodesk called "Sustainability in the City" that highlights how architects are implementing specific sustainable strategies and tactics in actual design projects. Additionally, a new summer season of The Architypes Project podcast will be launching soon, featuring unique guests with architecture degrees who have pursued alternative careers.

I look forward to seeing you all at Grassroots. We have almost 300 registrants, five tracks of content (Leadership, FBD, Career, Innovation, Lifestyle), six keynotes aligned to each track as well as design, Quad receptions at architecture firms including HOK, CallistonRTKL, Gensler, and Fox Architects, and as always, our Friday night BBQ at AIAS Global Headquarters. Welcome Chapter Presidents!!! The AIAS National Office and Board of Directors is ecstatic to host you in Washington, D.C., the city that Rachel (Past VP) and I have called home for the last year. Grassroots is by far my favorite conference of the year, not only for the relationships that are formed and the great ideas that are sparked, but for the anticipation of a year full of hard work and incredible results. As a chapter president, you have already stepped up to take responsibility for the betterment of your chapter. You will be asked to step up many more times throughout the year. Know that you are ready for that and you are capable of achieving all of the goals set out at Grassroots and much more.

Since the exercise was outlined as solely fictional, it allowed everyone to think way beyond the current expectation of possibilities and come to their own conclusions on what AIAS should be doing now to encourage, or in some cases, prevent their proposed futures for the architecture profession.

#### **PARTNERSHIPS - FBD**

It has also been a huge opportunity this year to work with the NCARB partnership with Freedom By Design to expand the service portfolio. Freedom By Design saw some huge leaps this year that will continue to make it a more relevant and necessary component of AIAS and architecture education. The Board's decision to expand this program should not be overlooked as the most crucial element to the future success of Freedom By Design. We chose to be more open, more relevant, to not be defined by limitations but by opportunities. This is the mindset that will continue to lead architecture students for years to come.

#### **COLLATERAL REPRESENTATION**

Even though my term as AIAS President will end in just a few days, my time as Student Representative on the AIA Board of Directors will extend all the way until December!! Similarly to any AIAS position, it feels like you only truly understand the position once your time is almost up. With the AIA, we're still considering ways to make a professional organization more relevant to architects, and architects more relevant to the public. These discussions have been so valuable for the AIAS to both have a voice in and continually learn from as we look to what's next for our members.

With the AIA, I am also serving on the Public Outreach Committee, the committee responsible for providing feedback on the television advertising strategy as well as the #ilookup campaign. That process has been so fun to see how the rhetoric we choose to describe architecture truly makes a difference in our relevance. I'm looking forward to getting even more invested with this committee as Past President.

Several weeks ago, the NCARB Experience Advisory Committee just wrapped up. I was so excited to serve on that committee as a current licensure candidate myself. Some of the most interesting work that came out of those meetings was research into the architecture license process in other countries around the world. I was surprised to learn that the US has one of the most rigorous processes for architects and the profession is more highly regarded in the US than it is in most other countries. That was both encouraging and eye-opening as to the reality of how much the efforts of our 5 collaterals have paid off in advocating for our profession.

#### ABOUT ME

We serve all 90,000 AIA members and are focused on expanding knowledge, increasing prosperity, diversifying the workforce, and driving public outreach for the profession. My activities within the Strategic Council focus on the knowledge portfolio. I serve on the Board's Knowledge Committee and convene other counselors on design topics impacting our cities. In the past, I have held various leadership positions through the AIA, including the national leader of the Interior Architecture Committee and the President of AIA Columbus. I love to learn, and also appreciate the comradery which develops.

#### THE NEW URBAN AGENDA

I would encourage all of you to read up on the New Urban Agenda. This is a plan which was adopted by the United Nations in October of 2016 after the Quito, Ecuador Habitat III conference. The New Urban Agenda sheds light on the increasing need to address global urban population growth. The AIA's Strategic Council is working to prototype an engagement initiative called the Communication, Advocacy, and Policy of the New Urban Agenda (CAPNUA), which will heighten interest in the New Urban Agenda, educate communities to the potential associated with planning, and strengthen future design outcomes across the country. This initiative will be administered in geographically and culturally diverse locations of various scales. Plans are in place in Columbus, Austin/San Antonio, Omaha, Honolulu, Indianapolis, and Miami. Each city will bring a unique, localized structure to their engagement project. In Indianapolis and Austin, the program will be linked to regional architectural conferences. In other communities, the engagement will be jointly supported by organizations representing landscape architects and planners and focused on compelling local issues.

If you reside in or near one of these communities, you are encouraged to contact your local AIA office and engage.

#### **RESILIENT DESIGN**

Resilient design seeks to improve our built environment to withstand the ravishes of flood, drought, tornadoes, hurricanes, wild fires, and earthquakes. Currently, the Institute has programming to support the education of architects on relevant topics, and the Disaster Assistance Program has established a network of architects to help communities before and after a disaster.

The AIA is exploring a credential program. This program, which could be similar to LEED certification, could augment knowledge and skills in the area of resilient design, and help architects prepare to assist and lead prevention and recovery in the face of future natural disasters.

#### A'17

This year's conference on architecture was held in Orlando and featured a number of inspirational keynote speakers. My favorite day supported the theme "Anticipate Need: Design that Cares" and featured Michael Murphy co-founder of Mass Design, Elizabeth Diller, founding partner of Diller Scofidio + Renfro, Francis Kere, and Alejandro Aravena. These architects delivered a message which was a call to action for the profession to lead all societies towards an improved human condition.

The conference also featured an interview with lawyer, writer, and former First Lady Michelle Obama. Ms. Obama shared personal stories and offered hopeful viewpoints which were encouraging to many attendees. She encouraged architects to seek projects which benefit lowincome communities: "Yes, there are the projects that happen downtown – that important building, that important park – but there's also those community centers, those parks and district facilities, the homes, the opportunities that you have to make a neighborhood beautiful for a family or a child



that feels like no one cares. So I would urge you all to think about that, as you look at the next project that you take."

#### **AIA MEMBERSHIP**

Did you know that you are eligible for up to 18 months of free membership in the AIA upon graduation from an NAAB accredited architecture program? We want each and every one of you to join, engage, and contribute to our profession's future. When asked, I often share the incredible impact that the AIA has had on my practice endeavors. 

#### ABOUT ME

It is an honor to serve the AIAS board and be a part of the exciting work that is being performed by both this organization and the future leaders of our profession. This year marks 17 years of my service to NCARB through the South Carolina Architects Licensing Board, working and chairing the Architect Registration Examination (ARE), working on various Architect Experience Program (AXP) initiatives, developing the new Integrated Path to Architect Licensure (IPAL) program and serving on the national board in various capacities culminating in my serving as the 2015/2016 National Council of Architectural Registration Boards (NCARB) president. This service has positioned me to be a voice for students and young professionals, leading the call for options and choice in education and experience while advocating the value of licensure.

After obtaining my Masters of Architecture degree from Clemson University and studying at the Charles E. Daniel Center for Design in Genoa, Italy, I began my internship with Intergroup Architects of Denver, Colorado. Currently, I am a practicing architect and president of a 12 person

firm in Florence, SC specializing in the design of Public Education, Higher Education, Healthcare and Senior Care facilities with a focus on project types that must address individual needs typically with restrictive funding. Because of this, we advocate for quality design and value regardless of the project type and situation while meeting the needs of our clients. Through my NCARB Certificate, I currently hold licenses to practice in Georgia, North Carolina and South Carolina. In addition to my service with NCARB, I spearheaded the effort to create the Florence, SC AIA Component where I served as chair and followed as a director on the AIASC board. I also serve as



a NCARB visiting team representative for the National Architectural Accrediting Board (NAAB) where I have been either a team member or chair of numerous visits to Schools of Architecture throughout the country in that capacity.



#### FREEDOM BY DESIGN PARTNERSHIP

The Freedom by Design partnership between the AIAS Clemson chapter, the Clemson University Gift and Giving Foundation and the professional community is now up and running. The sponsor request letter written jointly by AIAS Clemson officers and myself has been sent to all South Carolina registered architects and firms. Donations are currently being received. The hope is that this will make it easier for the chapter to generate funds for their FbD project while architects and firms would find greater benefits in donating directly to the university rather than to the chapter. This assistance from university fund raising programs should generate additional funds to support more/larger FbD projects while involving the practice and licensing board in integrating education into practice...deliverables important to NCARB for continued financial support for the FbD program.

#### FbD AND NCARB

Mike Armstrong (NCARB CEO) presented an FbD update to the BOD during its April meeting. The report stated that AIAS Chapters and Licensing Board FbD partnerships had grown to 16 jurisdictions expressing interest in being a part of an overall project. (AL, CA, HI, MN, MI, NV, NH, NJ, NM, OH, RI, SC, TN, VA, WI) Proposed changes were discussed and well received by the BOD. Discussion centered on the benefits of the partnership:

- Students gain an earlier understanding of the existence and role of the licensing boards
- Volunteer Member Board Members partner with students as design mentors
- Students earn experience credit in AXP
- Each AIAS project is established as a community based design center collaborative with both licensed architect and builder oversight
- NCARB BOD reviewed the results of the \$100K grant to AIAS in 2016 to provide an infusion for grants to programs, development of marketing materials and operational support
- The BOD was asked to consider additional grant funding beyond the current \$100K. A final determination is expected during the June FY17 BOD meeting budget discussion.





#### INTEGRATED PATH TO ARCHITECTURAL LICENSURE (IPAL)



The 2017 call for IPAL applications was released at the end of January. Several more NAABaccredited programs wishing to integrate the AXP and the ARE into the curriculum submitted their initial applications in early spring. Participating students must be able to complete the AXP and must be able to sit for each division of the ARE prior to graduation. Applications have been reviewed and NCARB staff has coached programs with incomplete submissions to assist in a successful final application. New programs accepted to participate will be formally announced during the June 2017 annual business meeting. **Currently 17 programs offering 21 paths have been accepted** with 14 programs completing their inaugural year at the end the 2017 spring semester. It is anticipated that the volume of new programs wishing to participate will decrease exponentially. NCARB understands that IPAL may not be compatible with every program's mission, but simply wants to insure that students have a selection of options from which to choose when determining their personal paths.

To position the candidate/program for success, NCARB has developed a tracking matrix to follow each student in the IPAL experience. This data, gathered in the spring of 2017, will be compiled for the first of an annual delivery beginning in the summer of 2017.

#### ARE 5.0 CUT SCORE



NCARB officially launched the new Architect Registration Examination (ARE) November 15, 2016. All divisions have exceeded the number of deliveries required to determine the Cut Score. This cut score is the minimum threshold **number of items that must be answered correctly to pass each division exam**. A substantial number of candidates are taking advantage of the combined exam package where, when taken in the correct combination, the seven ARE 4.0 divisions and the six ARE 5.0 divisions can be completed in only 5 divisions. During its April board meeting, the BOD finalized the cut scores for all six divisions which will now begin the instant grading process in lieu of the 4-6 week grading process for the ARE 4.0. The previous ARE 4.0 will continue to be offered concurrently with the new ARE 5.0 through June 30, 2018 at which time all candidates will take ARE 5.0.



#### **TEST PREP PROVIDERS**

NCARB is preparing a new initiative to credential ARE 5.0 test prep providers as "NCARB Approved". This credentialing process will assure examination candidates of the legitimacy and accuracy of their materials.

#### MUTUAL RECONITION ARRANGEMENT WITH AUSTRALIA AND NEW ZEALAND

The NCARB Member Boards voted overwhelmingly to support a new recognition arrangement with Australia and New Zealand during their June 2016 Annual Business Meeting in Seattle. 29 jurisdictions ratified the arrangement with it taking effect in January 2017. NCARB is excited to announce that **US architects have begun receiving reciprocal licenses**.

The ability of an architect licensed in a U.S. jurisdiction to lawfully seek and find work abroad depends on their ability to become licensed in that foreign jurisdiction. The Mutual Recognition Arrangement between NCARB, the Architects Accreditation Council of Australia (AACA), and the New Zealand Registered Architects Board (NZRAB) further expands the reach of U.S. architects enabling them to establish professional contacts, seek work, and perform services as a registered architect "down under.", similar to the current agreements with Canada and Mexico.





#### NCARB THINK TANK

During Forum, many students came to me and asked how they might be able to participate as a NCARB volunteer. I introduced this question during the January NCARB BOD meeting which initiated a lively discussion. NCARB realizes the value of the student voice. Our Licensure Advisor initiative has proved highly successful. While many of our committees are exposed to sensitive material that pertains to licensure; inappropriate for non-licensed candidates, there are other possibilities. **President Harding has charged staff with reviewing options** such as joining the current think tank, creating a student think tank, expanding the Student Licensure Advisor program or serving on appropriate committees. These are options are to be brought before a future BOD meeting for further discussion. #### STUDENT LICENSING ADVISORS



LICENSING ADVISORSSUMMIT JULY 27–29, 2017 CHICAGO

In an ongoing effort to facilitate licensure, NCARB continues to develop and expand its *Student Licensing Advisors* program and is seeking additional students to support their peers as they begin the licensing process and have you participate in their *"Licensing Advisors Summit"*. Funded by



NCARB, student licensing advisors from more than 35 programs attended the previous summit. This year's summit will be held in Chicago later this month. Participating in this community will better prepare you to assist your peers on their paths to licensure while helping the entire licensing advisor community deliver important programming messaging. Having a Student Licensing Advisor in your program can also bring additional benefits to your chapter. These collaborative efforts will not only assist you in retaining your existing AIAS members, but can help to encourage new members by providing additional value of membership. This past year 2 Student Licensing Advisors received FREE registration to Grassroots courtesy of NCARB. If interested, please let me know and I will make the appropriate connections.

#### **EXPECTATIONS and ACTUALITIES**

As I complete my first year as the AIAS NCARB Liaison, it is appropriate to reflect on expectations and actualities. My expectation was to provide a strong focus on outreach and communication to keep both organizations informed of the value of partnership. It is important that the student voice is heard as NCARB continues to restructure its programs to create options and choice. This was certainly realized, especially through the NCARB/AIAS FbD Partnership. In actuality, NCARB better understands the value of the student voice and its positive impact on our programs; the need for a stronger mentoring relationship; the importance of collaboration not just from the point of graduation but from the start of one's formal education; and finally, the energy, excitement and "anything-is-possible" approach of the AIAS. Thank you for the opportunity to serve and with expectations of even greater successes, I look forward to even greater actualities.

I believe that the supplemental information provided by Nick before our semiannual reviews allowed us to have confidence when reviewing the finances with him. These exercises allowed for our members to grow through their participation on the committee in a way that is unique to what this committee can offer.

#### Where We Are Going

We are so grateful to have a body of members that challenges us to be honest, transparent, and creative. Next year will be an audit year for the finance committee. As such, we expect there to be a larger focus directly on preforming the audit and less of a focus on communicating membership value to our constituents.

As a new committee of the AIAS, I have quite enjoyed the challenge of leading a new charge with such an excellent partner! It has, no doubt, had a few rocky moments, but I am quite happy with what we have done this year.

In the early days, the team began by auditing CRIT and the Honors and Awards Process; an exercise which led to retooling of the HA timeline, and which provided great insight into increasing the value of CRIT. From there, we began the discussion of competitions, the value of them to our members, where their interests lie, and how often they are submitted to. This dialogue led to a deeper understanding of student time lines and work loads, leading to the desire for competition requiring production to take place outside the academic year. This is now reflected in the placement of third party competition releases on our calendar, and the creation of the InStudio Instagram Competition to launch next year.

From that point forward, we organically discussed the value of AIAS to the each of us in the design studio and how this impacted the paths we've taken and the work that we have done thus far. We then analyzed how our individual Chapters viewed the AIAS in regards to design and where the low hanging fruit for growth existed.

As Maria and the team rounded the corner towards the home stretch, we once again looked towards the mantra of #VisibleValue. As a means of communicating the work that the Think Tank has done of the past year, we felt a series of testimonials would do well to actively communicate the design side of our mission statement. Through a series of brainstorming dialogue, the committee gravitated towards the concept of Designers of AIAS: a visual way of showcasing this. The series highlights one member per week on our Instagram Channel. Maria's submission is seen below.
