

#### Question:

There may be things that you feel the AIAS could do better, or maybe you see new opportunities or partners to engage. Where do you see room for improvement or new areas for the organization to expand into?

#### **Response:**

The AIAS provides some wonderful opportunities for national engagement through things like conferences but for many Chapters, only a few members or members in leadership positions are able to take part in these opportunities. Providing a national connection for all chapter members who wish to take part is one of my goals. Creating a mentorship program open to all body members of each Chapter in the Northeast Quad would give a more "national" experience opportunity for all members of the Northeast Quad. This program would pair students of different years in their education from different schools in the Northeast Quad to create a platform for the sharing of ideas and peer critiques. The emphasis of the work to be shared in this program would be centered around the architectural portfolio. The portfolio is, in many aspects, one of the keys to the professional world. Continuing to support students to apply their schoolwork to their future careers is a way for AIAS members to gain more value from their associated with the organization.



# QUESTIONAIRE

### **Question 3**

#### Question:

In recent years, the AIAS has increased its efforts in advocacy for architecture students on issues including but not limited to health and wellness, equity, student loan debt, Learning & Teaching Culture, practice experience, leadership, and technology. What one issue do you personally find the most important? How would you make progress on this issue as an elected leader on the AIAS National Board of Directors?

#### **Response:**

An architectural education is something that can change from school to school. Many students who I have interacted with feel underprepared for many of the tasks they are asked to complete as part of a studio project whether it is model making, structural design, or economic analysis. Advocating for a system of teaching that delivers knowledge to students when they need it is a challenge that I have taken up and that I would continue if elected to the national board. In my own chapter this past semester I have hosted a panel that brought together nine professionals including representatives from the client, contractor/construction management sector, and architects. The panel was titled "The Economics of Architecture." This panel discussion gave students' knowledge regarding the economics of the profession and how collaboration is key to success. This panel along with a model-making workshop hosted by the Alfred State chapter is just one step in the direction of an architectural education that fully prepares students for studio projects and more importantly for the industry of architecture. If elected Northeast Quad Director, I would create resources to help Chapters gain mentorship from professionals. This includes making sure all Chapters in the Quad have a good relationship with their local AIA Chapter and helping to give them a voice when reaching out to these Chapters. The opportunity for students to be in the same room as professionals helps to boost them into the professional field. Assisting Chapters in facilitating events with AIA members will give students the chance to voice their questions and gain valuable insight to be applied to their studio projects as well as their future careers.

### **Question 4**

#### Question:

The AIAS has over 250 chapters across the U.S. and around the world, ranging in size, age range, and even purpose. How would you use your position on the Board to better connect and engage our geographically and culturally diverse membership? What resources would you propose to better serve Chapter leaders seeking to grow their chapters and connect to other students around the world?

#### **Response:**

The diversity and broad reach of the AIAS is something that is unparalleled by many student organizations. This is what makes the AIAS so unique; continuing to expand access to this broad range of experiences and knowledge is something that I believe should be strengthened.

Creating a regional virtual workshop highlighting strong events such as a beaux arts ball or model material store hosted by chapters with expertise in these events. This type of event would give chapters from around the Quad the opportunity to learn best practices for hosting events.

#### **Question:**

Describe how you intend to fulfill the roles and responsibilities of your chosen position on the Board. Elaborate on your intended communication/action plan and the primary goals you have for your one-year term.

#### **Response:**

My path through architecture school has shown me that **collaboration and communication are key to success**. This has been made apparent to me through my experience working in studio as a group project manager, my professional experience, and my position as Chapter President. At Alfred State I have had the chance to work as a project manager in a community revitalization project where the scope was an entire village. This project showed me that a clear, yet adaptable plan and consistent communication will create the greatest chance of success. My work as an intern has shown me that **communication comes in many** forms; working in person in an office environment has taught me to pay attention to details and always have a notebook on hand to document important points. Working on projects in a firm has additionally shown me that graphics are crucial when it comes to communication in the field of architecture whether it is a marked-up document or a diagram. My work at Chapter President through organizing events has given me the insight that **communication must be clear and to the point for the best results**.

As Northeast Quad Director, I would use this experience to **adapt my communication to each chapter**. I understand that every Chapter leader communicates in their own unique style. 
#### PROGRAM STATEMENT: This building provides place for creative individuals to research and fabricate


HIGH LINE CONNECTION STAIR








CONFORM GREEN SPACE FOR SOLAR



## AMERICAN INSTITUTE OF ARCHITECTURE STUDENTS POLICY ON COMPENSATION FOR INTERNS

In July 1993, the AIAS Board of Directors adopted a "Public Policy on Uncompensated Interns." The policy has been subsequently reviewed and reaffirmed by the Board and reads as follows:

The AIAS maintains that employers must properly compensate all employees. Compensation must be in compliance with the regulations for the jurisdiction in which they are working.

In 2010, AIAS crafted a public statement on intern compensation in conjunction with the Association of Collegiate Schools of Architecture and the American Institute of Architects, which reads as follows:

The Association of Collegiate Schools of Architecture, the American Institute of Architects, and the American Institute of Architecture Students recognize that architects are bound by law and ethics to pay interns, and strongly advocate for the appropriate compensation of architectural students and interns. Because of current economic transformations, some architects have both solicited and accepted the services and labor of interns without pay. We strongly urge architectural firms and other for-profit employers to respect the law and comply with the ethical standards of our profession, and we strongly encourage interns to refuse to accept employment without pay, and to notify the Department of Labor in cases where employers propose such an arrangement. For more information on labor laws and professional ethics, please see the AIA Code of Ethics and the U.S. Labor Department standards under the Fair Labor Standards Act.

The ACSA, AIA, and AIAS further support architects, students, and recent graduate doing pro-bono work. We recognize the distinction between unpaid work for profit-making employers, and unpaid work for non-profit organizations, communities in need, and volunteer activities, which allows participants to determine their own hours and degree of involvement. The AIA has established guidelines for service that are provided on a Pro Bono basis. They can be found under the member section of the AIA website.

#### POLICY ON COMPENSATION FOR INTERNS AFFIRMATION

As a way of confirming that the AIAS is not promoting or being promoted by architects employing unpaid interns, we ask that each participant in an official AIAS function review and sign the following statement. We appreciate your participation in our event and thank you for your support of our position against unpaid internships. This position is supported as well by the Board of Directors of the Association of Collegiate Schools of Architecture (ACSA) and the American Institute of Architects (AIA).

#### AMERICAN INSTITUTE OF ARCHITECTURE STUDENTS ELECTIONS CODE OF ETHICS

Elections are a critical step by which the American Institute of Architecture Students is governed. Annual elections, as outlined in the Bylaws and the Rules of the Board, ensure that the membership of the organization participates in the selection of the best candidates to serve on the national Board of Directors.

Individuals elected to the Board of Directors represent the membership and ensure the continued success of the organization. Therefore, participants who are involved in the elections process, including candidates and Board Members, are expected to demonstrate the highest standards of professionalism, integrity, and good judgment.

Confidentiality is required of all participants in the elections process. Participants should not discuss details of the elections process to the general membership before, during or after FORUM. Elections information that is considered public knowledge, and therefore can be shared with the membership, occurs during the General Business Sessions and at the General Assemblies.

Campaigning is strictly prohibited prior to FORUM. Conversation between chapters regarding candidates should not take place. Campaigning will only begin at the first General Assembly of FORUM.

Campaigning during FORUM shall be professional. Candidates and candidate support groups should be respectful in their campaigning efforts. Disrespectful campaigning will be a violation of the Elections Code of Ethics, and will be grounds for immediate review by the Past President.

Campaigning materials should follow the Election Guidelines, and should be distributed in appropriate venues only. Appropriate venues include FORUM General Business Sessions, General Assemblies, and Quad Breakouts.

As leaders of this organization, and future leaders of this profession, we must uphold the highest ethical practice. Questionable behavior during elections will not be tolerated. Any concerns should be immediately raised with the Past President.
